



CLINICAL HISTORY: A. HPV+, r/o CIN D. vulvar lesion, condyloma

DIAGNOSIS:

- (A) Cervical LEEP biopsy @ 12 o'clock: Chronic cervicitis and squamous metaplasia. Benign endocervical tissue
- (B) Cervical LEEP biopsy @ 10-3 o'clock: Mild squamous dysplasia (CIN-1/HPV)

Comment: Ki-67 and p16 immunostains also support the above diagnosis. Margin negative for dysplasia.

(C) Cervical LEEP biopsy @ 3-8 o'clock: Flat condyloma

(D) Rt Vulvar biopsy: Condyloma accuminatum

Comment: Ki-67 and p16 immunostains also support the above diagnosis.

(E) Lt Vulvar biopsy: Condyloma accuminatum

Comment: Ki-67 and p16 immunostains also support the above diagnosis.

GROSS DESCRIPTION:

(A) Cervical LEEP biopsy @ 12 o'clock: Received in formalin, labeled with the patient's name, and "cervical biopsy" are two strips/irregularly shaped fragments of soft/friable tissue measuring 2.5 x 1.2 x 0.4 cm in aggregate. Entirely submitted in a tissue processing bag.

- (B) Cervical LEEP biopsy @ 10-3 o'clock: Received in formalin, labeled with the patient's name, and "cervical biopsy" is a strip/irregularly shaped fragments of soft/friable tissue measuring 1.5 x 0.8 x 0.4 cm. Entirely submitted in a tissue processing bag. One block.
- (C) Cervical LEEP biopsy @ 3-8 o'clock: Received in formalin, labeled with the patient's name, and "cervical biopsy" is a strip/irregularly shaped fragments of soft/friable tissue measuring 1.5 x 0.8 x 0.4 cm. Entirely submitted in a tissue processing bag. One block.
- (D) Rt Vulvar biopsy: Received in formalin, labeled with the patient's name, and "vulvar biopsy" are two strip/irregularly shaped fragment of soft/friable tissue measuring 0.4 x 0.3 x 0.3 cm in aggregate. Entirely submitted in a tissue processing bag. One block.
- (E) Lt Vulvar biopsy: Received in formalin, labeled with the patient's name, and "vulvar biopsy" is a strip/irregularly shaped fragment of soft/friable tissue measuring 0.3 x 0.3 x 0.2 cm. Entirely submitted in a tissue processing bag.

 One block.
